Risks include, but are not limited to: injuries resulting from patrons' negligent misuse of the facilities, climbing walls or equipment; cuts and abrasions resulting from ropes or skin contact with the climbing wall; failure of the facilities, climbing walls, or equipment of BCR; slips, trips, falls, or other, in using the facilities, walls, or equipment of BCR; personal health problems, physical conditions, or other personal areas of concern; individual or collective negligence of the owners, employees, or volunteer assistants, other climbers, visitors, or persons who may be present acting in an individual capacity; negligence or lack of adequate training of any person(s) who seek to assist with medical or other help.

I have been warned and am aware of these and numerous other inherent risks in using the Beach City Rock Gym facilities, climbing walls, and equipment. I fully and voluntarily **assume complete responsibility** for those risks and for the injuries that may occur as a result of those risks even if injuries occur in a manner that is not foreseeable at the time I sign this agreement.
